On Tuesday, August 23<sup>rd</sup>, Brad and Allen Clark, Steve Michell and myself delivered sixteen Fire Barrels throughout the community. Eight of the barrels needed to be filled with water from the tank on Brad's truck. We used the nifty Water Filling Station near the Ballpark to fill the tank on Brad's truck. The Regional District will be covering half the cost of the Fire Barrels and Buckets.

The position of Protective Services Manager for Area F has not yet been filled, but interviews are in the process. It will be nice to have that person lead the way in terms of: revising our evacuation plan; coordinating with the Local Planning Groups (LPG); and start the process of reducing fuel loads. We have been lucky with the weather so far this year, which has taken some of the pressure off these projects.

With the recent hot and dry weather, this is a good time to ready your fire fighting equipment and locate and deal with fire hazards around your home.

Are your hoses ready and in good working order? Debris under decks are an often neglected hazard. Cutting grass in the heat of the day can be dangerous.

## **Bad things happen when good people fail to speak out and take action.**

As the founding President of the Kingfisher Interpretive Centre, I am compelled to point out that this is the first time in 10 or more years that the Annual General Meeting of the Kingfisher Interpretive Centre is being held in accordance with the Constitution and bylaws/ B.C. law - as in the right month and all members being notified.

Just before we all cheer that the board is recognizing B.C. law, let's review some facts.

The present board is in noncompliance of no less than seven different areas of their Constitution and Bylaws. They are in noncompliance with both the old and new 'conflict of interest' policies. They are in noncompliance with the majority of the policies they have written this year.

No matter how professional or pretty a constitution, bylaws and policies are, they are pointless unless all directors and members uphold them.

So why compliance with B.C. law/ AGM bylaws now? - they need to do things legally to register the changes they are proposing to the constitution and bylaws.

The proposed changes will greatly reduce members' rights and privileges, giving directors extraordinary powers and authority over the society and its members.

This is the exact opposite of what BC's new society act is trying to achieve, which is "Make directors more accountable to their members".

Kingfisher Interpretive Centre was created and built by the Kingfisher Community and other people throughout the Fraser River basin. Myself and other members beseech YOU to come to this AGM Sept. 14, whether you are a member in good standing, a past member, or a member of the general public - as allowed under BC law.

It behooves all of us who care and love this organization, to assist the next generations in achieving their dreams and reaching the potential that they see for this organization in the years to come.
